



## **WILDLIFE MONITORING & WILDLIFE POLICY**

1. Our hotels are not aware of and fully comply with current local, national and international regulations and guidelines on wildlife monitoring and wildlife interactions.
2. Our staff will be trained to protect wildlife and ensure a sustainable interaction in all activities of our hotels. This training will be regularly renewed and updated in collaboration with local nature conservation organizations and experts.
3. Our hotels are committed to supporting projects that will support wildlife efforts to protect and sustain natural habitats. These projects can include areas such as habitat restoration, the creation of wildlife sanctuaries, and the sustainable management of local ecosystems.
4. We will provide guests with informative materials on wildlife conservation and respect for the natural environment, and we will inform them of local regulations and guidelines. We will also encourage guests not to disturb or endanger wildlife and not to pollute natural habitats.
5. Our hotels will take the necessary measures to prevent activities and practices that may disturb wildlife and will act in accordance with local regulations. This includes not interfering with wildlife in natural migration routes, nesting sites or feeding areas, and preventing damage to local fauna and flora.
6. Our hotels aim to provide guide services to inform our guests about wildlife viewing and wildlife interactions, and to encourage participation in tours to local nature reserves. These tours will be conducted in a regulated and nature-friendly manner suitable for wildlife observation.
7. Our hotels will collaborate with local conservation organizations and relevant stakeholders to protect wildlife and promote sustainable tourism practices. These collaborations may include supporting scientific research, implementing projects for the restoration of natural habitats, and engaging local communities in wildlife conservation efforts.
8. Our hotels will identify potential risks that may disturb wildlife within the facility and take the necessary measures to minimize these risks. These measures include the designation of special zones for the protection of natural habitats, the implementation of garbage and waste management policies, and the adoption of practices that promote the sustainable use of natural resources.
9. Our hotels aim to raise awareness of local communities by organizing wildlife conservation trainings, seminars and events. These activities aim to encourage local people to appreciate wildlife, protect natural resources and contribute to sustainable tourism practices.
10. Our hotels are committed to the continuous review and improvement of wildlife conservation and sustainable tourism practices. In this context, we will follow local and international regulations, consider new scientific findings and adopt best practices.



11. Our staff will be continuously trained to ensure full compliance with the hotel's wildlife policy and to provide accurate information to our guests. They will act sensitively and responsibly in wildlife conservation.

12. Direct interactions, in particular nurturing, based on the advice of an unaffiliated wildlife expert, are not permitted unless specifically approved or non-existent by internationally recognized standards. Such interactions can affect wildlife's natural behavior, lead to potential health risks, and disrupt local ecosystem balance. For this reason, we will take care to control direct interactions with wildlife in our hotels. This policy reflects our Hotels' commitment to wildlife conservation and sustainable tourism practices. All our staff and guests are responsible for complying with this policy and are expected to actively contribute to our Hotels' wildlife conservation efforts.
